Introduction – House Keeping

This focuses on criminal incidents on West Main Street within a ½ mile radius of Main/Sheridan. This report covers incidents from November 1st, 2014 till November 30th, 2014. This is the second report since the migration from a 90 day report to a monthly report. As such, trend data is still being collected and will be included in reports moving forward.

Report - Aggregated Data

From November 1st, 2014 till November 30th, 2014, within a ½ mile radius of Main/Sheridan:

5 aggravated assault incidents, 0 of which were on West Main
2 burglary/theft from vehicle, 0 of which were on West Main
1 burglary garage, 0 of which were on West Main
10 burglary residence, 0 of which were on West Main
6 drugs, 0 of which were on West Main
8 property damage, 0 of which were on West Main
2 robbery, 1 of which were on West Main
5 theft, 1 of which were on West Main
1 vehicle theft, 1 of which were on West Main
4 weapons incidents, 0 of which were on West Main

Overall Analysis

Within a ½ mile radius of West Main and Sheridan, there were 44 total incidents in a 30 day period and 3 of those happened on West Main, or approximately 6.82% - a decrease of 0.87%.

During the same time, Peoria County had 848 incidents reported. Of that, 5.19% of reported crime happened within a ½ mile radius of W Main/Sheridan, and crime on West Main accounts for 0.35%. Due to the modification in the reports structure (moving from 90 days of data to monthly) trend data has been removed and will become part of the report of a future report.

In Peoria City, there were 710 reported incidents. Of those incidents, 44 transpired in a ½ radius from W Main and Sheridan – 6.20% of the reported incidents for Peoria City. Of those 44 reported incidents, 3 transpired on W Main which accounts for 0.42% of reported incidents for the Peoria city.

Note: Trend data has been removed from this report due to a change in the structure. The previous report was a 90 day report. Trend data will renew and be ongoing during in the near future. Sorry for the inconvenience.
